#### CONFERENCE AIMS – PRIORITIES

Gender-based discrimination is often manifested in the laws, policies, institutions and practices of many countries and cultures of the world. For example, in many countries women are not given the same opportunities as men to reach decision-making positions, including positions in public and political life. Even if there are constitutional guarantees providing for equality and laws protecting women's rights, discriminatory practices by law enforcement and services can stand in the way of women's security and access to justice.

With these and other challenges in mind, the conference will take place and intends to be a forum, discussion and networking place for academics, researchers, professionals, administrators and policy makers interested in the intersection of gender, law and institutions. Thus, the organizers

invite proposals from any academic discipline with respect to practice and/or research concerned with the conference's main priorities. The **priorities of the conference** are:

- a) Gender, Human Rights and Law
- b) Gender and Employment
- c) Gender, Policies and Justice
- d) Gender and the Judiciary
- e) Gender, Political Life and Political Parties
- f) Gender, Power and Decision-Making
- g) Gender and the Police
- h) Gender and the Military
- i) Gender and Media
- j) Gender, Research and Higher Education

The programme of the conference includes 3 keynote speeches by experts in gender studies and law:

- (1) **Loraine Gelsthorpe**, Professor of Criminology and Criminal Justice, Institute of Criminology, *University of Cambridge, UK*
- (2) **Maria Drakopoulou**, Reader in Law, Kent Law School, *University of Kent, UK*
- (3) **Nestor Courakis**, Professor of Criminology, Law School, *University of Athens, Greece*

## PROPOSALS

- The language of the conference is English
- Proposals are invited on the conference themes/priorities. Proposals for papers, posters and symposia are welcomed
  - **Papers** are presented as a standard presentation, for which the presenter will have 20 minutes to present and answer questions.
  - **Symposia** involve at least three linked papers, presented together by a group. The chairperson is decided by the presenting group while the time for a symposium is limited to one conference (1,5h) session regardless of the number of the papers.
  - **Posters** are presented on a standard A1 sized page and elaborate on some area of research, ideas or expressions. The presenter stands by his/her poster and discusses it with the participants of the conference during a timetabled poster session.
- Papers for the conference will all be presented and discussed in a 20 minute slot. A paper of up to 4,000 words may be submitted for circulation at the Conference and, if of sufficient quality, will be published in the Conference Proceedings. You will be able to edit your paper after the Conference and resubmit it.

## WHAT TO INCLUDE IN THE PROPOSAL FORM

Please find attached to this Second Call for Proposals the **Proposal Form** (find it also in the UNESCO Chair's website), which you should fill in with the required information as follows:

- Type of proposal (Indicate whether the proposal concerns *paper*, *poster* or *symposium*. In case of a symposium, please include all the required information for each paper in the proposal)
- Conference priority (please choose 2 priorities in which your proposal falls into)
- Title of the proposal (max. 20 words)
- People involved in the proposal and affiliation details
- **Abstract.** Please include aim, research questions, conceptual or theoretical framework with at least three theoretical references, methodology, research instrument(s), methods or sources used, conclusions, expected outcomes or findings (max. 1000 words)
- References (the most important ones) (max. 400 words)

## HOW TO SUBMIT YOUR PROPOSAL FORM

Your proposal form MUST be submitted via email ([unescoeq@ucy.ac.cy](mailto:unescoeq@ucy.ac.cy)) as an attachment by **1 September 2014**. Regrettably we cannot consider proposals submitted after this date.

## CONFERENCE BOOKINGS AND REGISTRATION

### ▪ TRAVEL/ACCOMMODATION

The conference will be held at the University of Cyprus (75 Kallipoleos str.), Nicosia, Cyprus. Nicosia is easily accessible from Larnaca (Larnaca International Airport, 51 km) or Pafos (Pafos International Airport, 86 km). To get to Nicosia you can take a bus (Kapnos Airport Shuttle) which will drop you off at the centre of the town where you can take a taxi to your hotel. The bus ticket costs 8 Euros (from and to Larnacaairport) and you may need an additional 8-10 Euros for the taxi (from the bus stop to your hotel). There is a taxi stand as you come out of the arrivals' hall at Larnaca airport.

You are responsible for making your own travel arrangements to/from Nicosia and for booking your own accommodation. Please note that the conference organizers CANNOT make accommodation bookings on your behalf, provide travel advice or arrange your travel for you.
